

**ORDINANCE NO. 929**

AN ORDINANCE MAKING AND LEVYING A SPECIAL TAX UPON ALL LOTS AND PARCELS OF GROUND IN THE CITY OF CHETOPA, KANSAS LIABLE FOR THE COST AND EXPENSE OF MOWING IN SAID CITY DURING THE MONTHS OF SEPTEMBER AND OCTOBER 2019 AND CONDEMNATION EXPENSES FOR MARCH, JULY-OCTOBER 2019. BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF CHETOPA, KANSAS:

SECTION 1. That a special tax is hereby levied upon and against the premises in the City of Chetopa, Kansas, herein after described and the amount set opposite there to respectively, for the payment of the cost and expenses for mowing in said City of Chetopa during the months of September and October 2019 and condemnation expenses for
