

ORDINANCE NO. 988

AN ORDINANCE AMENDING SECTION 15-301 OF THE CITY CODE OF THE CITY OF CHETOPA, KANSAS, AND AMENDING ORDINANCE NO. 932, RELATING TO ELECTRICAL RATES WITHIN SAID CITY AND OUTSIDE THE CITY LIMITS.

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHETOPA, KANSAS:

SECTION I. That Section 15-301 of the City Code of the City of Chetopa, Kansas, be and hereby amended to read as follows:

15-301. RESIDENTIAL AND COMMERCIAL ELECTRICAL RATES.

(a) The residence rate for electricity furnished by the City of Chetopa shall be as follows:

- (1) Inside the city limits:
 - Customer Charge \$27.50 per month
 - Usage Charge (all kWh) 0.129433 per kWh
- (2) Outside the city limits:
 - Customer Charge \$27.50 per month
 - Usage Charge (all kWh) 0.140515 per kWh

(b) The industrial and commercial rate for electricity furnished, whether inside or outside the city limits, by the city shall be as follows:

- Customer Charge \$38.50 per month
- Usage Charge (all kWh) 0.123504 per kWh

(c) The wholesale rate for electricity furnished to all city owned entities shall be as follows:

- Customer Charge None
- Usage Charge (all kWh) 0.118264 per kWh

SECTION II. All electrical usage in the area served by the City of Chetopa may be subject to application of an Energy Cost Adjustment (FA). The rates for energy to all customers may be increased by 0.001 cents per kilowatt-hour (kWh) for each 0.001 cent or major fraction thereof, increase in the aggregate cost of energy per kWh as computed by the following formula:

$$Adjustment = \frac{E}{P} - b \times 1.12 \text{ loss factor}$$

Where:

- E = Total cost of purchased power, energy, and transmission thereof, and all other related costs therefore, including, without limitation, transmission and power supply studies.
- P = kWh purchased from wholesale suppliers for the current month.
- b = Base cost of \$0.054153 per kWh.
- 1.12 is for the 12% loss from unmetered city owned entities.

This adjustment may be made each month and shall be computed on the cost of energy purchased during the monthly period immediately preceding the period for which the energy is furnished. Any amount added to a monthly bill under the ECA shall not be reduced by any other adjustment. Any month where the ECA computes as a negative number a zero adjustment will occur. Application of the ECA during any monthly period shall be at the option of the city.

SECTION III. This Ordinance shall be in force and take effect on the 6th day of August 2024.
