

**ORDINANCE NO. 994**

**AN ORDINANCE PROVIDING FOR SALARIES AND WAGES OF CERTAIN APPOINTIVE OFFICERS AND EMPLOYEES OF THE CITY OF CHETOPA, KANSAS AND REPEALING ORDINANCE NO. 964 AND ALL OTHER ORDINANCES IN CONFLICT HEREWITH.**

BE IT ORDAINED BY THE GOVERNING BODY OF THE CITY OF CHETOPA, KANSAS:

Section 1. That the following named officers and employees will receive an annual compensation for their services and CLASSIFICATION BY PAY RANGE:

1. \$2,400 - \$20,000  
City Attorney  
Municipal Judge  
Cleaning Position  
Fire Chief\*  
Fire Department Secretary/Treasurer\*

\*Compensation will not be paid to the Fire Chief or Fire Dept Secretary/Treasurer if they are a member of the governing body per the Fire Department Bylaws.

2. \$8,000 - \$65,000  
City Helper  
Office Worker  
Water Plant Operator  
Police Sergeant  
Police Officer  
Mow Person
3. \$30,000 - \$90,000  
Utility Bookkeeper  
City Supervisor  
Court Clerk/Asst. Bookkeeper/Asst. Clerk  
Water Plant Supervisor  
City Clerk  
Police Chief

Section 2. Other employees and officers shall be compensated at the following rates:

All Extra Labor	Minimum wage or as determined by the Governing Body.
Firepersons	All fire calls, with or without using water or chemicals \$4.00 per fire per person For attendance at monthly meetings \$4.00 per meeting per person
First Responder	\$20.00 per run.
Mayor/City Council	\$20.00 per meeting, actually attended, both regular and special; and committee meetings, provided there shall not be more than four (4) meetings in one (1) month.
City Treasurer	\$400.00 per year.
City Attorney	Besides compensation as provided for by Section 1 above, the City Attorney shall be paid an additional \$120.00 per hour for all Municipal Court prosecution, civil litigation, administrative hearings or any other litigated type of matter.

Section 3. That all salaries provided for in the foregoing sections of this ordinance shall be paid by warrant checks duly drawn, signed and issued as provided by law.

Section 4. That all salary levels provided for in the foregoing section of this Ordinance shall be effective February 04, 2025.

Section 5. That ordinance No. 964 is hereby repealed.

Section 6. That this Ordinance shall be in force and take effect upon its summary publication in the official City Newspaper.
